As you will be aware, sir, sheduled 10 to the draft development consent order contains the draft protective provisions. And these are made up of three sets of protective provisions. Firstly, for the protection of electricity, gas, water and sewage undertakings, which is part one, and then provisions for

the protection of electronic communication code networks, which is part two, and finally, provisions for the protection of the environment agency, which is part three. Now, through through ourselves, DLA Piper. substantive discussions as to protective provisions are currently underway with both northern gas networks and National Grid gas

in relation to Northern gas networks, and meeting was held most recently on the 19th of February, discuss protective provisions. And I can confirm that a draft asset protection agreement is currently in circulation and is currently with northern gas networks for review.

# 07:17

In terms of the points which have been discussed, I can confirm there aren't any major points of contention. And I think it's fair to say both parties are confident that agreement be reached during the course of the examination.

### 07:29

Similarly, in respect of national grid gas discussions are ongoing. And in particular, in relation to the points raised in the written representation, which was submitted by National Grid gas that deadline to and then responded subsequently, by housing that deadline three, and again, that there is a side agreement currently being prepared by DLA Piper on behalf of highways England. And similarly, we don't anticipate there being any major points of issue on that.

And so in addition to those two parties, and DLA Piper have also made contacts with each of the environmental agency, Northumbrian water and Northern powergrid, to discuss both protected provisions and also progress them to common ground, which we can we can deal with later. And to date, we haven't had substantive discussions with these parties as to protective provisions. But we are we are very happy to you going forward. And would also note, of course, that tshechu attend to the draft DCA contains protective provisions which cover those interests.

So I think with reference to the agenda, sir, where substantive discussions are underway, we don't consider that to be any insurmountable differences of view. And further where discussions haven't commenced, I think we would say we continue to rely on the draft protector provisions set out in the draft DCA in terms of a timescale, I don't think we're yet able to commit to a specific deadline for for agreements to be completed with northern gas networks and National Grid gas. But as I said, there aren't any major points of contention. And of course, we will continue to write updates through the statements of common ground.
