Application by Highways England for an Order Granting Development Consent for the A1 in Northumberland - Morpeth to Ellingham

Procedural Decisions and Notification of Hearings

This letter provides you with details of Procedural Decisions made by the Examining Authority (ExA) and notification of Hearings that will be held during the weeks commencing 7 June 2021 and 14 June 2021.

Publication of Further Written Questions (ExQ3) and the ExA's Proposed Changes to the draft Development Consent Order (dDCO)

In line with the Examination Timetable published as Annex A to our Rule 8 Letter of 6 January 2021 [PD-008] and the Revised Examination Timetable published as Annex A of our Rule 8(3) Letter of 9 April 2021 [PD-014] we confirm that under item 23 we will be publishing Further Written Questions (ExQ3) tomorrow, 11 May. Item 23 of the Examination Timetable also indicated that the ExA would publish its proposed schedule of changes to the dDCO if required. Having given careful consideration to all representations in respect of the dDCO, the ExA has decided that only one change to the dDCO is proposed at this stage and this is included as a question within ExQ3 (DCO.3.7).

Notification of Hearings under Section 91 and 92 of the Planning Act 2008

The ExA has decided to hold Hearings in the weeks commencing 7 June and 14 June 2021. The Hearings during the week beginning 14 June will be in relation to the Applicant's request for changes to the Proposed Development which were accepted into the Examination as set out in our letter of 9 April 2021 [PD-014]. Notice of the dates, times and format of these Hearings is provided in Annex A along with other

important information about these events including details about the requests to be heard and the procedure that will be followed at Hearings.

Due to the issues around COVID-19 the ExA has made the Procedural Decision that these Hearings will be held by virtual means, through Microsoft Teams.

As set out in the Examination Timetable annexed to our letter of 6 January 2021, those Interested Parties who wish to speak at the Hearings should notify the Planning Inspectorate's Case Team by emailing A1inNorthumberland@planninginspectorate.gov.uk if you wish to participate in these Hearings as soon as possible and no later than 28 May 2021. We would be grateful if you would inform us if you plan to attend a Hearing even if you do not wish to speak.

For those that do not wish to participate in the Hearings there is the opportunity to observe them in real time via a livestream link which will be published on the project page of the National Infrastructure Planning website shortly before the start of the Hearings. Alternatively, a full digital recording of the event will be made available on the same webpage as soon as possible after the close of the Hearings.

Issue Specific Hearings and Compulsory Acquisition Hearings

Procedure at Hearings

The procedure to be followed at Hearings is set out in The Infrastructure Planning (Examination Procedure) Rules 2010. Any oral representations must be based on either the Relevant Representation or Written Representation made by the person by whom, or on whose behalf, the oral representations are made.

The ExA is responsible for the oral questioning of a person giving evidence and the process affords very limited scope to allow cross-questioning between parties. Our examination will be principally undertaken through the exchange of written submissions, and we will decide whether a Hearing on a particular issue or topic is necessary. This decision is not connected to how relevant or important we consider an issue or topic to be.
