1 INTRODUCTION

1.1 INTRODUCTION

- 1.1.1. This Application Document Tracker (this 'Tracker') relates to an application for a Development Consent Order (DCO) made by Highways England (the 'Applicant') to the Secretary of State for Transport via the Planning Inspectorate (the 'Inspectorate') on 7 July 2020 under section 37 of the Planning Act 2008 (the '2008 Act'). If made, the DCO would grant consent for A1 in Northumberland: Morpeth to Ellingham (the 'Scheme').
- 1.1.2. The application was accepted for examination on 4 August 2020. This Tracker was prepared in response to a Procedural Decision issued by the Examining Authority on 5 August 2020 which requested this Tracker be provided prior to commencement of the Relevant Representation period.
- 1.1.3. This is a live document and will be updated and submitted, when updated, for each examination deadline to help the Examining Authority and interested parties understand the application as it evolves through examination by identifying the latest version of any application document. This Tracker has been updated and submitted at Deadline 11.
- 1.1.4. A change request was also submitted at Deadline 4. These changes were accepted for examination by the Examining Authority on 9 April 2021 and are now considered by the Applicant to form part of the Scheme. The relevant documents are now incorporated into the main table below and superseded previous versions where appropriate.

1.2 APPLICATION DOCUMENT TRACKER

- 1.2.1. This Tracker provides a full list of all the application documents submitted to date, indicating the latest version and when an updated application document is submitted now the Scheme is in examination.
