I am hereby notifying you under Section 46 of the Planning Act 2008 that Highways England ('the Applicant') intends to apply under Section 37 of the Planning Act 2008 for a Development Consent Order (DCO) for the A12 Chelmsford to A120 widening scheme.

### **Consultation Information**

Highways England will be undertaking statutory pre-application consultation under Section 42 of the Planning Act 2008 between **22**<sup>nd</sup> **June 2021** and **16**<sup>th</sup> **August 2021**. We would also like to draw your attention to the fact that in addition to this being a highways scheme under the Planning Act 2008, the proposed scheme includes changes to a number of existing utilities. These changes include the diversion of two high pressure gas pipelines operated by Cadent Gas Limited. The first high pressure gas pipeline is located between Springfield in Chelmsford and Little Braxted running along the southern side of the A12 within the local authority areas of Chelmsford and Braintree. The second is located between the Witham Bypass and Little Braxted running along the south of the A12 also in the local authority area of Braintree (the Diversions). To the extent that the Diversions satisfy the criteria to be considered an NSIP under section 20 of the Planning Act 2008, the Diversions will be treated as NSIPs in their own right.

Even though the Diversions may be treated as NSIPs in their own right, as they are part of the proposed scheme they will form part of the application for development consent which will be made by Highways England to the Secretary of State for Transport. To the extent the Diversions are an NSIP in their own right they would also be considered against the relevant energy National Policy Statements within the application.

### **Consultation arrangements**

All consultation materials will be available online at there is also a virtual exhibition, where people can find out more about the webinars we will be hosting and the scheme in general. In addition, and subject to the government COVID road map, a series of public consultation events and pick up locations will be available. The times of the public consultation events and the pick up locations are set out in the SoCC and will also be included on the website. We have directed consultees to the website for further information about these elements due to the uncertainty caused by COVID-19. Further details of the consultation arrangements can be found on the website and in the enclosed Section 48 Notice.

I am hereby notifying you that National Highways ('the Applicant') (formerly known as Highways England) intends to hold a supplementary consultation on changes made to the design in response to Statutory Consultation comments. National Highways will apply under Section 37 of the Planning Act 2008 for a Development Consent Order (DCO) for the A12 to A120 widening scheme (the scheme).

National Highways will be undertaking supplementary pre-application consultation between **9**<sup>th</sup> **November 2021** and **19**<sup>th</sup> **December 2021**. The proposed scheme includes changes to a number of existing utilities. These changes include the diversion of two high pressure gas pipelines operated by Cadent Gas Limited. The first high pressure gas pipeline is located between Springfield in Chelmsford and Little Braxted running along the southern side of the A12 within the local authority areas of Chelmsford and Braintree. The second is located between the Witham Bypass and Little Braxted running along the south of the A12 also in the local authority area of Braintree (the Diversions). To the extent that the Diversions satisfy the criteria to be considered an NSIP under section 20 of the Planning Act 2008, the Diversions will be treated as NSIPs in their own right.

### **Supplementary Consultation**

The statutory consultation on the proposed scheme closed on 16 August 2021. As part of the proposed scheme's continuing development we are now undertaking a supplementary consultation on changes we have made to the proposed scheme, including the following proposals:

- removal of Junction 21 Southern link road, so the traffic will use a new and enhanced northern link road via Wellington Bridge to access the proposed junction 21 alongside walkers, cyclist and horse riders
- removal of proposed noise barriers through Hatfield Peverel to be replaced with improved road surfacing with better noise performance,
- options for Gas Main Diversion corridors near Witham,
- temporary removal of a noise barrier at Market Lane to enable construction of the proposed scheme,
- local road interventions at Inworth Road,
- closure of Easthorpe Road access to the A12 (except walkers, cyclists, horse riders, emergency services and private agricultural access).

In addition to the changes described above, this supplementary consultation also includes a number of additional changes to the design captured within the brochure and/or on plans and tables with a description of the change. The changes are split into 3 categories explained below:

**Category 1:** the main changes we are proposing as a result of our updated design which are likely to result in a change to the environmental information we presented at statutory consultation. These changes are presented in more detail in the brochure.

**Category 2:** further changes as a result of our updated design, these may also involve an environmental change but those are considered to have a less significant environmental impact

and are potentially more localised. These are detailed in a schedule on page 42 of the brochure.

**Category 3:** minor changes as a result of our updated design. The majority of these will not involve a change to the environmental information we presented at statutory consultation and which are generally more localised in nature.

In addition, and subject to the government COVID guidelines, a series of physical drop-in events and pick up locations will be available. We have directed consultees to the website for further information about these elements due to the uncertainty caused by COVID-19.
