#### Issues to be observed

Our property has been made into an island, surrounded on all sides by the proposed work and the Inspector needs to see exactly how this will impact our lives and the peaceful enjoyment of our home.

#### Access

Our cottage can be seen and accessed from the B1023 road and we would welcome an on-site inspection

#### Reason

Our 250+ year old cottage is a rare example of traditional Essex weatherboard construction and has been in our family for 85 years. The proposed scheme will severely impact our lives, causing disruption, noise, pollution and stress. We live in very close proximity to the A12 and Park Bridge-and will have to endure overnight working, piling, light and noise pollution. Furthermore, we are surrounded by proposed haul roads that will be used for the transport of materials from the borrow pits in the field opposite our cottage.

As a result of this scheme, the value of our property will be severely diminished and, almost certainly, we will not be able to find a buyer prepared to purchase it at a price reflecting its prescheme, value.

For the record, we are both 75 years old and our health and mental wellbeing have already been adversely affected by the stress caused by this scheme. Consultations and plans for it have been going on for several years putting us under a constant threat.
