#### 1 Introduction

#### 1.1 Purpose of this document

- 1.1.1 SoCGs are a useful and established means of ensuring that the evidence at the DCO examination focuses on the material differences between the main parties, and so aim to help facilitate a more efficient examination process.
- 1.1.2 The SoCG has been produced to confirm to the Examining Authority where agreement has been reached between the parties to it, and where agreement has not (yet) been reached. SoCGs are an established means in the planning process of allowing all parties to identify and so focus on specific issues that may need to be addressed during the examination.
- 1.1.3 The purpose of the SoCG is to set out agreed factual information about the proposed DCO application. It is intended that the SoCG should provide matters on which both parties agree. As well as identifying matters which are not in dispute, the SoCG may also identify areas where agreement has not been reached.
- 1.1.4 It is envisaged that this SoCG will evolve during the examination phase of the DCO application.
- 1.1.5 Any subsequent drafts will be agreed and issued, with the version numbers clearly recorded in the 'Document Control' table at the beginning of the document.
- 1.1.6 This Statement of Common Ground ("SoCG") relates to an application made by National Highways Limited ("the Applicant") to the Planning Inspectorate ("PINS") under Section 37 of the Planning Act 2008 ("PA 2008") for the A12 Chelmsford to A120 Widening Development Consent Order ("the DCO"). If made, the DCO would grant consent for the Applicant to undertake the A12 Chelmsford to A120 Widening Scheme ("the Scheme").
- 1.1.7 A detailed description of the Scheme can be found in the ES Chapter 2 "The Proposed Scheme" [6.1 Environmental Statement Chapter 2 The proposed scheme (planninginspectorate.gov.uk)].
- 1.1.8 This SoCG does not seek to replicate information which is available elsewhere within the Application documents. All documents are available in the deposit locations and/or the Planning Inspectorate website:

#### 1.2 Parties to this Statement of Common Ground

- 1.2.1 This SoCG has been prepared by (1) the Applicant and (2) Cadent Gas Limited (Cadent Gas).
- 1.2.2 National Highways became the Government-owned Strategic Highways Company on 1 April 2015. It is the highway authority in England for the strategic road network and has the necessary powers and duties to operate, manage,



- maintain and enhance the network. Regulatory powers remain with the Secretary of State.
- 1.2.3 Cadent Gas is the UK's largest gas distribution network and their assets are affected by the scheme.
