The Documents submitted in volume 7 have been updated to reflect comments received during examination.

The Design Principles document has been updated to reflect comments about Cadent Gas design Standards and Essex Police Guidance provided with the interested party relevant representation.

The Outline Construction Traffic Management Plan has been revised to include some changes to address some issues raised at relevant representation by Interested Parties

In terms of those documents submitted in Volume 9. Additional Submissions, these are explained below.

Supplementary species surveys are being submitted [documents 9.15, 9.16 and 9.17] to provide the results of surveys undertaken in autumn 2022 for a single land parcel (Blue Mills) along the proposed gas main diversion (Little Braxted to Springfield A1A2). This area was not covered by the original suite of surveys reported on in Appendix 9.8 of the ES.

A Riparian Mammals Survey Report [document 9.18] has also been submitted to present the findings of surveys undertaken in summer/autumn 2022 along a stretch of the River Blackwater where crossed by the proposed gas main diversion to the south of Whetmead Local Nature Reserve (LNR) and Local Wildlife Site (LWS).

The Applicant is also submitting the following:

• a document containing the Applicant's comments on information received at Deadline 1 [TR010060/EXAM/9.19].



- a document summarising the changes the Applicant proposes to make to the draft Development Consent Order to be submitted at Deadline 3 [TR010060/EXAM/9.20].
- a technical note on the 'Inclusion of construction and operational maintenancerelated greenhouse gas emissions within the Benefit Cost Ratio (BCR)' [TR010060/EXAM/9.21]. The purpose of this document is to describe the sensitivity test that was undertaken for the proposed scheme, where estimated construction and operational maintenance-related greenhouse gas (GHG) emissions are monetised and included in the BCR.
- a Materials and Landscape Palette [TR010060/EXAM/9.22] which sets out how the design principles referenced in the Design Principles [APP-280] will be translated into the physical form, by providing visual indicative examples of materials and landscaping palettes.
- A Reptile Survey Report [TR010060/EXAM/9.23]
