The Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 –
Regulation 10(1) Application for a Scoping Opinion and Regulation 8(1)(b) Notification

I write with reference to the above Development, for which we intend to apply for development consent under the Planning Act 2008.

With reference to Regulation 10(1) of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ("EIA Regulations 2017"), I write to apply for a scoping opinion from the Secretary of State in respect of the Development. I also confirm that Highways England proposes to submit an environmental statement in respect of the Development for the purposes of Regulation 8(1)(b).

Please find attached the information required under Regulation 10(3) of the EIA Regulations 2017 and Section 7 of Advice Note Seven (Environmental Impact Assessment; Process, Preliminary Environmental Information and Environmental Statements), namely:

- the Environmental Scoping Report which includes at Chapter 2 a description of the proposed development, including its location and technical capacity, and at Chapters 6 to Chapter 16 an explanation of the likely significant effects of the development on the environment; and
- the GIS shapefile which identifies the land for which the request for scoping opinion is made.

The DCO boundary (Red Line Boundary) provided has been developed for scoping purposes, and is subject to further design and assessment work as the DCO application is progressed. This indicative DCO boundary shown in the attached shapefile has been derived using the latest design for each scheme. For those schemes where a single route alignment is being developed, the indicative DCO boundary includes land that will be required for the scheme and an allowance of land for mitigation based on the current stage of assessment. For those schemes where alternative route alignments or significant junction options are being considered, however, the design is not sufficiently developed to determine an indicative DCO

boundary. A 250m buffer has been applied to the centre line of each of the alternative route alignments to derive an indicative DCO boundary for these schemes. This buffer has been amended only where it intersects with substantial settlements to remove the more densely populated areas from the boundary, however where properties remain within the buffer this should not be taken to mean those properties will definitely be affected by any of the alternative alignment or junction options being considered for the project.
