#### 1 Introduction

### 1.1 Purpose of this document

- 1.1.1 This Schedule of Negotiations relates to National Highways' application to the Planning Inspectorate under the Planning Act 2008 (the "2008 Act") for the A66 Northern Trans-Pennine project Development Consent Order 202x ("DCO"). If made, the DCO would grant consent for the Applicant to undertake the A66 Northern Trans-Pennine project (the "Project").
- 1.1.1 A detailed description of the Project can be found in Case for the Project (Application document 2.2).
- 1.1.2 This Schedule of Negotiations has been prepared and submitted in compliance with Regulation 5(2)(h) of the Infrastructure Planning (Applications: Prescribed Forms and Procedure) Regulations 2009 (the "2009 Regulations"), as amended, and in accordance with the Department for Communities and Local Government guidance 'Planning Act 2008: Guidance related to procedures for compulsory acquisition' (September 2013).
- 1.1.3 As this Schedule of Negotiations is part of the application documentation it should be read in conjunction with the Book of Reference (Application document 5.7), Land Plans (Application document 5.13), the Crown land Plans, (Application document 5.14), the Special Category Land Plans (Application document 5.25), the Statement of Reasons (Application document 5.8) and the draft DCO (Application document 5.1).
- 1.1.4 The Applicant seeks to acquire interests in the Land required for the Project by agreement wherever practicable. The current status of negotiations with affected landowners for the acquisition of their land interest is set out in this Statement. National Highways will continue to progress negotiations on an ongoing basis.



# 2 Schedule of Negotiations Description

# 2.1. Schedule of Negotiations Notes

2.1.1 Each plot of land listed in this Schedule of Negotiations relates to the Book of Reference and has been given a unique reference. The first number relates to the relevant scheme of the Project, the second number relates to the Land Plans sheet on which the plot is located. The third number differentiates between each plot sequentially. The numbers given to each plot are generally assigned from west to east across each sheet.
