Please can I draw attention to two matters.

1. The email address shown in Annex H (List of prescribed consultees identified and consulted) shows the incorrect spelling of this Council's preferred email address for consultation. The address to use is planning@hambleton.gov.uk (see page 44 of Annex H, which shows @hableton...)
2. The link to the zip file (a 1.6GB file) is considered an inappropriate way to supply these documents. The download size is unacceptably large and could perhaps have been better provided with a secure link to access the relevant files rather than downloading the whole zip file.
