Points to be made

1. This is a plea for the A66 to go north of the current A66 rather than south on the Appleby Brough section 06, and especially at the proposed new Langrigg Junction, as in the current plans.

2.Instead of enlarging the present road south of the existing road, and causing noise and disruption to the present buildings, the creation of a good wide route somewhat further north could be a great success. It would enable visitors to the

area to enjoy the beauty of trees and fells now hidden by huge trees along the present road.

3. These views in themselves would be an attraction to visitors to the area. It would be worth coming to visit simply to enjoy them along with some easy walking. A good wide road could be built to allow a good number of cars etc to enjoy it without the damage and upheaval which enlarging the A66 to the south of the current road would cause, impinging on good fields and beautiful trees. Some visitors might also enjoy climbing the beautiful low fells in the area.

4. The road to the north of the current A66 could be a bit further north than where farming is needed.

5.A "northern route" would not be damaging anyone else's living space, which is the case with the current proposals.
