Extract from letter dated 15 November 2022

The Councils do not have a specific request for an accompanied site visit to Scotch Corner (Scheme 11) or Mainsgill Farm Shop and Moor Lane Junction (Scheme 9) following the unaccompanied visits to those sites.

The Councils consider it is appropriate at this stage to point out the potential for the Town and County Planning Act application at the Moor Lane junction. The Councils understand this will include the development of a large compound with accompanying infrastructure developments including a temporary roundabout at the junction to Moor Lane. The Councils do not have any more detail than that at this stage and early discussions are being scheduled. Had this application been part of the DCO it is likely that the Councils would have suggested an accompanied site visit was appropriate given the scale of the proposed compound. The Councils leave it to the discretion of the Examining Authority as to whether it considers a further site visit in light the proposed TCPA application would be appropriate.
