### 1.1 Purpose of the document

1.1.1 The below table sets out the Applicant's proposed itinerary for the Accompanied Site Inspection (ASI), due to take place on Tuesday 28<sup>th</sup> February 2023 (if required). The Interested Parties requested various ASIs via the Planning Inspectorate and the Applicant has incorporated all of these below.
