#### 1 Introduction

### 1.1 Purpose of this document

- 1.1.1 This part 4 table of the Scheme 06 Book of Reference ("the table") relates to National Highways' application to the Planning Inspectorate under the Planning Act 2008 (the "2008 Act") for the A66 Northern Trans-Pennine project Development Consent Order 202x ("DCO"). If made, the DCO would grant consent for the Applicant to undertake the A66 Northern Trans-Pennine project (the "Project").
- 1.1.2 A detailed description of the Project can be found in Case for the Project (APP-008).
- 1.1.3 This table has been prepared and submitted in accordance with a request from the Examining Authority, made during Compulsory
  Acquisition Hearing 2, held on 1 March 2023. They show the Crown Land on Scheme 06, and have been updated to include two plots which were previously omitted namely plots 06-03-34 and 06-03-38.
- These plans should be read in conjunction with the updated Book of Reference for Scheme 06 submitted at Deadline 5 of the examination. They should also be considered in conjunction with the Land Plans for Scheme 06 (APP-307), the Statement of Reasons (REP2-012) and the updated draft DCO submitted at Deadline 5.
- 1.1.5 The Book of Reference submitted at Deadline 5 includes details of the interests identified in the Crown land within the Order limits shown on these plans or identified as being affected by the Project.
- 1.1.6 The Order limits include Crown Land held by the Secretary of State for Defence.
- For the avoidance of doubt, any land held by National Highways no longer constitutes Crown land (as defined in section 227 of the 2008 Act). A transfer scheme made pursuant to the Infrastructure Act 2015 states that the "Highways Agency Designated Undertaking" which is defined as the property and rights which were held for the purposes of Relevant Highways Agency Purposes (activities carried out by the Highways Agency or those which concerned functions relating to the highways) is transferred to National Highways (formerly Highways England). This includes, for example, all highways in England previously under the jurisdiction of the Highways Agency unless they have been specifically excluded. As the Applicant is not a government department nor does it hold said interests on trust, these plots are not considered to be Crown land.
- 1.1.8 The Crown land identified in Part 4 of the Book of Reference for Scheme 06 is shown on the Crown Land Plans for Scheme 06, as submitted by the Applicant to the Examining Authority at Deadline 5 (Document Reference 5.14, Rev 2)
