Council Changes

Following changes which came into force on 1 April 2023, the Applicant is aware that a new unitary authority, Westmorland and Furness Council is now in operation and has replaced Cumbria County Council, Eden District Council, Barrow Borough Council and South Lakeland District Council. In addition, a further new unitary authority, North Yorkshire Council is now in operation and has replaced North Yorkshire County Council and Richmondshire District Council as well as six other district councils. Westmorland and Furness Council and North Yorkshire Council are local authorities defined by Section 43 of the Planning Act 2008 for the purpose of the A66 Project. Due to the time of writing, our Deadline 6 submissions continue to refer to the original Council names, however we will use the new Council names of Westmorland and Furness Council and North Yorkshire Council for future Deadline submissions when referring to relevant authorities replaced by these councils.
