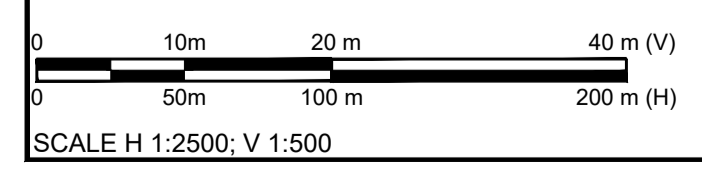

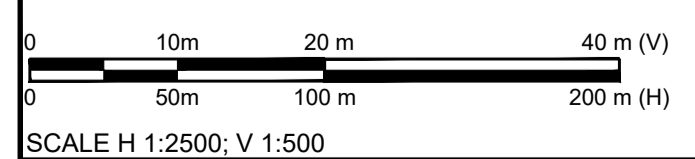

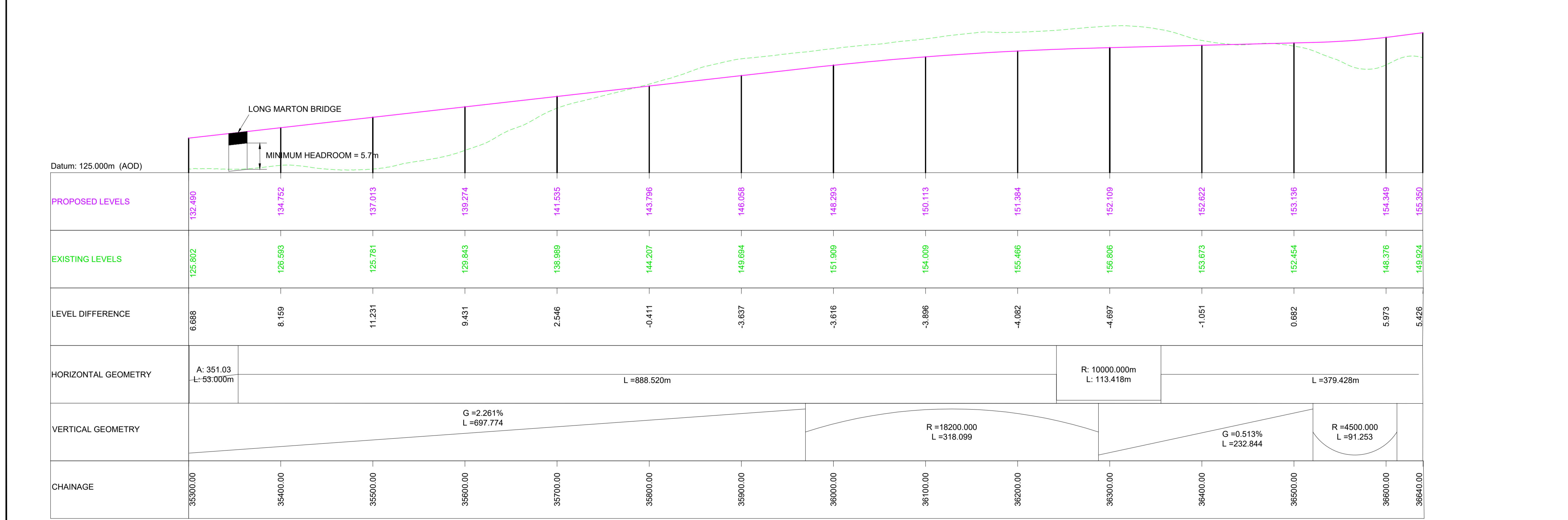


SCHEME KEY PLAN (MAINLINE)
