1 Introduction

1.1 Purpose of this document

- 1.1.1 This Schedule of Changes to the Book of Reference relates to National Highways' application to the Planning Inspectorate under the Planning Act 2008 (the "2008 Act") for the A66 Northern Trans-Pennine project Development Consent Order 202x ("DCO"). If made, the DCO would grant consent for the Applicant to undertake the A66 Northern Trans-Pennine project (the "Project").
- 1.1.2 The Project comprises eight schemes (as listed below) and this Schedule of Changes to the Book of Reference has therefore been divided into eight volumes, as explained in paragraph 1.1.3 below.
- 1.1.3 The eight volumes of this Schedule of Changes to the Book of Reference are aligned as follows to the eight schemes comprising the Project:
 - Volume One: Scheme 0102 M6 Junction 40 to Kemplay Bank
 - Volume Two: Scheme 03 Penrith to Temple Sowerby

 - Volume Five: Scheme 07 Bowes Bypass
 - Volume Six: Scheme 08 Cross Lanes to Rokeby
