CONSULTATION SEEKING COMMENTS FROM THE APPLICANT

REQUEST FOR INFORMATION

On 5 January 2024, the Secretary of State initiated a consultation inviting comments from the Applicant and all Interested Parties, the responses to which have now been published here. The Secretary of State is seeking comments from the Applicant as regards these responses, specifically on the below:

The Levelling-Up and Regeneration Act (2023)

1. The Secretary of State notes the submissions made by various parties, including Natural England, on the impact of section 245 of the Levelling-Up and Regeneration Act 2023 which came into force on 26 December 2023. The previous National Highways response of 20 December 2023 is noted. The Secretary of State is aware that guidance on the new duty is awaited from Defra and in that intervening period and without prejudice to that guidance, is intending to rely on the advice provided by Natural England. The Applicant is therefore invited to respond to the comments from Natural England and if thought helpful, to provide any supporting evidence that will help the Secretary of State in considering the application of the new duty.

Carbon Assessment

2. The Secretary of State notes the submission made by <u>Dr Andrew Boswell</u> regarding induced Heavy Goods Vehicles traffic and its implications for carbon emissions, specifically regarding the Applicant's approach to the assessment and the methodology used. The Secretary of States invites **the Applicant** to respond to this submission.

Cumbria Police

3. The Secretary of State notes the submission made by <u>Cumbria Police</u> outlining various concerns. The Secretary of State invites **the Applicant** to respond to this submission.

Any other comments

4. The Secretary of State invites **the Applicant**, if they wish to do so, to make any other final comments on the representations received in response to his consultation letter of 5 January 2024 in addition to any comments already provided to the preceding 3 questions.
