are refusing to pay any money. I've accepted the offer of their house of the house in August last year. My solicitor has been chasing for three or four 400 pounds to do a local search and the council will refuse to pay that money.

Lily Reed with Gloucester County Council solicitors. She's washed my hands

Mr. Beatty behind me they washed the hands of me. I'm not allowed to speak to my solicitor because they are not paid to do any work bark conveyancing.

He was recruited after my other surveyor left after 18 months because he wasn't getting anywhere with my claim.

He was recruited and once he saw my pile of expenses, which weren't literally that high. And they run out 120,000 pounds now.

he was told to stop working on those expenses. And he's only just since August been allowed to
