## 1. Guide to the Application

The Guide to the Application (TR010063/APP/9.26 – Rev 2.0) charts the submission of DCO application documents to the Inspectorate, identifying the current revision for all documents submitted by the Applicant into Examination. This is a live document and will be updated throughout the Examination process and submitted, when updated, for each relevant deadline.

# 2. <u>Draft Development Consent Order (dDCO) and Change Log, and Explanatory</u> Memorandum

The Applicant has provided an explanation for all changes made to the dDCO (TR010063/APP3.1 – Rev 3.0 in its Change Log (TR010063/APP/9.21 – Rev 2.0). The Applicant has provided a clean Deadline 3 version of the dDCO as well as two tracked copies. The first tracked copy compares Deadline 3 against the Applicant's Deadline 1 submission. The second tracked copy compares Deadline 3 against the original submission version.

In response to requests from the Joint Councils the Applicant has also updated the Explanatory Memorandum (TR010063/APP/3.2 Rev 1).

### 3. Statements of Common Ground and Statement of Commonality

The Statement of Commonality (TR010063/APP/8.1 – Rev 2.0) has been updated to reflect the current position with regards to the submitted SoCG's. Clean and Tracked version has been submitted.

Whilst the Applicant acknowledges that it had previously indicated the SoCGs with the various developers who have provided relevant representations and written representations would be submitted at Deadline 3, given the closure of the developer contribution methodology consultation, the Applicant considers that not enough progress has been made on the SoCGs. Draft SoCGs have been shared with the developers and the Applicant aims to progress matters in the SoCG and will update the ExA at the hearings and at Deadline 4.
