Proposed Changed to Development Consent Order – Change Application 2

This cover letter has been prepared by the Applicant to accompany the Applicant's Change Application 2.

The Notification of the Applicant's Intention to Submit Request for Proposed Changes to the DCO Application dated 12 August 2024 [AS-061] ("the Notification Letter") provided the details and background to the request for the proposed changes.

Further to this Notification Letter the Applicant confirmed in its cover letter for the submission of Change Application 1 [AS-062] its decision to split its proposed change application into two different applications:

- Change Application 1: this application includes the proposed changes that relate exclusively to upgrades in the rights the Applicant is seeking and engage the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 ("CA Regulations") and was submitted to PINS on the 4 September 2024 [AS-062 - AS-073]; and
- 2. Change Application 2: those that relate to changes in the design of the Scheme.

The Examining Authority (ExA) Rule 9 Letter dated 21 August 2024 [PD-011] acknowledged the Applicant's intention to submit a request for changes to the application and advised the Applicant to submit formal change request documents in accordance with the current Guidance "Nationally Significant Infrastructure Projects: Changes to an application after it has been accepted for examination" (Changes Guidance).

In line with the ExA's recommendation in the Rule 9 Letter, the Applicant has carried out targeted non-statutory consultation in respect of Change Application 2 in the spirit of the Infrastructure Planning (Environmental Impact Assessment) Regulations 2017 ("EIA Regulations"), despite our assessment showing none of the proposed changes generating new or different likely significant effects.

This submission is the Applicant's 'Change Application 2' and is to request for the following 7 design changes to be accepted for examination:







Change 1	Link Road replacement of swales with filter drain	
Change 2	Link Road replacement of culverts with bridges	
Change 3	Link Road River Chelt bridge structural form	
Change 4	Link Road alignment	
Change 5	Relocation of existing NRTS transmission station	
Change 6	Flood storage area reconfiguration	
Change 7	Infill of existing northbound on-slip loop	

The Applicant considers these changes to be relatively minor in nature, not altering the substance of the Scheme as applied for in December 2023.

- 4. [TR010063/APP/10.22] Schedule of Changes to the Statement of Reasons at Change application sets out the differences with the Statement of Reasons submitted at deadline 5 in relation to the new works descriptions included in the Change Application 2 draft DCO described.
- 5. [TR010063/APP/10.26] The Summary of Changes to Register of Environmental Actions and Commitments provides the draft wording which will replace the current entries, where relevant, within the REAC [REP4-018] should this Change Application 2 be accepted.

We trust that the documents submitted in support of this request provide a clear explanation and justification for them.
