You MUST make the request by completing the Event Participation Form by 23:59 11 November 2024 if you wish for either hearing to take place. If you simply wish to observe only the Hearings, then you do not need to register as you will be able to either: 1. watch a livestream of the event - a link to the livestream will be made available on the project



webpage shortly before the event is scheduled to begin; and/or 2. watch the recording of the event which will be published on the project webpage shortly after the event has finished. Please note that it may not be possible to participate on the day if you have not registered your wish to speak by 23:59 11 November 2024. If you are unable to complete the online Event Participation Form or require any support or assistance to attend the Hearings virtually, please contact the Case Team using the contact details at the top of this letter.
