1 Introduction

1.1 Purpose of this document

- 1.1.1 This Schedule of Changes to the Book of Reference (this "Schedule") relates to an application made by National Highways (the "Applicant") on 02 April 2024 to the Secretary of State for Transport via the Planning Inspectorate (the "Inspectorate") under the Planning Act 2008 (the "2008 Act") for a Development Consent Order (DCO). The application was accepted for examination on 30 April 2024. If made, the DCO would grant consent for the M60/M62/M66 Simister Island Interchange (the "Scheme"). A detailed description of the Scheme can be found in Chapter 2, The Scheme of the Environmental Statement (ES) [APP-041].
- 1.1.2 This Schedule should be read in conjunction with the most recent Book of Reference [AS-010] and Land Plans [AS-005]. This Schedule details changes in land ownership information arising from the transfer of property identified from an update provided by the Examining Authority.
