Environmental Statement Figures – Chapter 2 The Scheme - Figure 2.3 Environmental Masterplan of the [APP-057]

In responding to ExQ2 BIO.2.2 relating to Habitat Loss and Habitat Gain the Applicant has reviewed Figure 2.3 Environmental Masterplan of the Environmental Statement Figures [APP-057]. To assist with the interpretation of the Environmental Masterplan a table has been inserted to clarify which habitat type relates to which landscape description.

In undertaking this review the Applicant identified that the extent of the noise barriers and that of Public Right of Way 9WHI was not fully in alignment with the existing and so has been amended to the correct extent.
