Hi

I have been passed the SoCC for the Newark A46 bypass to review from an engagement perspective. In comparison with other planning SoCCs that I have recently reviewed for solar park planning applications, the document seemed rather light on information about stakeholders.

In particular, there was little stated commitment to engage with seldom heard voices. There is no information on how they plan to engage with seldom heard voices / people who may be less likely or may find it challenging to participate in the consultation process (e.g. some SoCCs have included an appendix of these groups). This may be addressed elsewhere in a document that I haven't seen or in a document from an earlier stage of consultation.

Reference is made in point 5.6 to having worked with other authorities on an Equality Impact Assessment, so this may be covered, but not spelled out in detail here.

I would like to see more reference made to the importance they place on inclusivity and their proposals for including seldom heard groups.



Thank you for forwarding the SOCC.

We recognise that the site and the outer distribution area for consultation material do not cross the District Council boundary and therefore we are not afforded the status as a host authority, nor will our residents receive information direct.

As a neighbouring authority with economic and housing growth ambitions embedded within the current Central Lincolnshire Local Plan 2017 and its review, which is imminently due for submission to the Planning Inspectorate for examination, the project is of significance to North Kesteven and our Central Lincolnshire partners (City of Lincoln and West Lindsey Councils). Much of the growth anticipated in our joint plan is within the Lincoln Strategy Area and therefore served in large part by the A46, and this includes the strategic employment allocations at Teal Park in Lincoln and St Modwen's Park at Witham St Hughs. Additionally for North Kesteven the A17 link is important again to sustain growth ambitions at Sleaford for two sustainable urban extensions and the development of the strategic Sleaford Moor Enterprise Park. The Council, and Central Lincolnshire, are represented at the relevant Trans Midlands Trade Corridor group.

For these reasons, the Council welcomes further consultation on this project and the opportunity for future submissions to be made as a neighbouring authority.

In terms of the SOCC itself, I am informed that in the NKDC context there are no known hard-to-reach or seldom heard groups in our area and in the immediate vicinity of the A46 that need to be consulted. However, there are a network of Parish Councils within the District that we would suggest need to be directly consulted and these include: Norton Disney, Witham St Hughes, Swinderby, Thorpe on the Hill, North and South Hykeham, Carlton le Moorland, Beckingham and Bassingham.

Finally, please could your database be updated such that future material is directed to me and I can then co-ordinate with colleagues.




