Dear Sirs

I have just submitted comments via the Planning Inspectorate website but wish to e-mail also to identify the Town Councils position.

Throughout the life of the proposals and the various stages of Consultation the Town

Council has changed its position from being supportive to opposed on several occasions. Decisions have often been resolved by small vote margins and in some cases by Chairmans casting vote. Significant changes in the make up of the elected Councillors following the 2023 local elections has also resulted in differing views emerging. The Councils Planning Committee met on the 10<sup>th</sup> July and resolved to submit comments to the pre-examination process which would state the Council as being against the proposals. This decision has been called in for scrutiny under our Standing Orders and will be discussed again on the 24<sup>th</sup> July. This however is after the closing date for pre-examination comments.

I would like to request an extension to the time period for submitting the pre-examination comments of Newark Town Council to the 25<sup>th</sup> July 2024.

In any event I have registered and hope that in doing so I have reserved the Councils ability to make submissions at the examination.
