## 1 INTRODUCTION

- 1.1.1 The document is an appendix to the Environmental Statement (ES) submitted as part of Luton Rising's application for development consent to expand London Luton Airport (the airport) from the currently permitted capacity of 18 million passengers per annum (mppa) to 32 mppa (the Proposed Development, as described in **Chapter 4** of the ES [TR020001/APP/5.01]).
- 1.1.2 Robust data was required to ascertain the sensitivity of receptors and open space resources to inform the Health and Community assessment reported in **Chapter 13** of the ES [TR020001/APP/5.01]. This included information on the demographics of users and patterns of use. This data was drawn from the questionnaire described below, completed with input from the users of the open space following the methodology described in **Appendix 13.1** of the ES [TR020001/APP/5.02]. The results of these surveys are provided in **Appendix 13.3** of the ES [TR020001/APP/5.02].
