My unique reference – 20039476

On Thursday August 17th 2023 I received an email from The Planning Inspectorate notifying me of the deadline of August 22nd 2023 to submit written representations following the initial hearing. In my opinion 5 days is an unreasonably short period to notify parties and to respond especially over the summer holiday period. This may prevent many from submitting their representations. A more reasonable approach would have been to make the deadline sometime in the first week of September and to send more than one notification email. This comes on top of that fact that the initial consultation for AD6 was conducted during the pandemic; a period of very low air traffic and unrepresentative of normal life. I was completely unaware of the consultation as were all of my friends that live in this area. Both this and the timescales for notification are unreasonable and suggest that the minimum amount of cooperation is being undertaken by the authorities for such an impactful project.

Summary of my written representations at August 22nd 2023:

Since AD6 aircraft noise has severely impacted our house and village. Low level aircraft frequently fly directly over our property. Our village is in rural North Hertfordshire and has very low ambient noise levels. The impact of low flying aircraft is significant. With recent natural disasters around the world I am also concerned about the environmental impact that the proposed Luton Airport Expansion might have. Furthermore, as mentioned above, the original AD6 consultation was flawed because of the pandemic and should be rerun. Thank you for your reply.


The consultation period was held during the extraordinary times of Covid so I and many others were unaware. Also aircraft traffic was minimal at this time. I think I've read that it was 10% of normal levels. As such, for those who were aware of the consultation, aircraft noise was not so 'front of mind'.

As for altitude and the associated noise levels, choosing to position flight paths over quiet rural areas seems like a flawed decision. The impact must surely be considered relative to ambient background noise rather than the absolute noise. Because our ambient noise levels and those of other rural areas are so low, the noise of aircraft at 5,000 ft and below is significant, whereas over urban areas it has a smaller impact as ambient noise levels are already higher. The impact on those who are currently affected by AD6 is only going to get worse if Luton Airport is allowed to expand, which makes it all the more important to get this right now. My family was sat in our garden yesterday evening and once again we had numerous low flying jets fly over, or very close to our house heading into Luton. On at least four occasions (there might have been more), aircraft altitude was closer to 3,000ft (see below) rather than 5,000ft. I do not have the time to record statistics for every plane on everyday but please believe me, the impact is significant.

Given the extraordinary circumstances (Covid) during the consultation period and the method of assessing noise impact in absolute rather than relative terms, the consultation should be rerun and the guidance for assessing noise impact should be reviewed urgently, with any resulting noise policy change having retrospective authority.

Many thanks for your recent email noise report to the Flight Operations team at London Luton Airport. I can confirm this complaint has been logged accordingly within our complaints database.

Earlier last year (February 2022) we implemented an airspace change which would have changed the tracks from aircraft in your area, this was a co-sponsored proposal from both NATS and London Luton Airport. The aim of this airspace change was to separate Luton's arrival routes from Stansted's arrival routes. The new routes were consulted upon from October 2020 – February 2021. We then submitted the airspace change proposal to the Civil Aviation Authority (CAA) in June 2021 with them granting approval in November 2021.

Furthermore, regarding the altitude of aircraft in your area, we check this daily as part of our ongoing monitoring. I have looked at recent data and can confirm that most aircraft are at the required altitude or higher. There may be some aircraft lower than the required altitude, and this is due to the weather conditions on the day. Aircraft use altimeters which is an instrument used to measure the altitude of an aircraft above a fixed level. This level is based on barometric pressure used to interpret how high they are – air pressure reduces with height, so the lower the pressure, the higher an aircraft altimeter will indicate. However, the weather also changes the air pressure so it may be slightly higher or slightly lower depending on the air pressure in the area, at the time.

When redesigning airspace we must follow the government guidance, this is currently to overfly the least number of people and therefore typically routes will overfly rural areas. I understand that this may cause more disturbance due to the lower ambient noise level, but we must comply with the government guidance in this regard. We will shortly be conducting noise monitoring around the area and once complete will create a community noise monitoring report.

There was significant media publicity throughout the consultation. Television news (BBC local and ITV local), and radio broadcasts (five by BBC Three Counties, one by BBC Radio Cambridgeshire and 16 by the local Heart Radio stations) highlighted the consultation launch in October 2020, with more broadcast coverage at the midpoint and again near the closing date. More than 50 editorial articles had a combined reach of 17.6 million people and social media promotions reached 1.2 million people. All of this coverage headlined the consultation and the principles of the proposed change and steered people to the virtual exhibition and consultation details.

Evidence suggests that the online consultation format made it straightforward for people to engage. More than 11,230 people visited the Virtual Exhibition, more than have ever attended local 'town hall' meetings in the past. As a result of this programme of engagement, and our significant efforts to set out the relevant information in a form relatable to the public, the consultation received 2,426 responses – more than any previous airspace change consultation.

Aircraft in your area will be receiving individual instructions from Air Traffic Control and therefore may not be at the same altitude or follow the same track each time. There are no set arrival routes or set altitudes for arrivals into Luton. The track and altitude will be based on other aircraft in the airspace at the time and this typically disperses the aircraft tracks over a wider area. This was the preferred option within the consultation (Option 1 in the consultation document).

There is a 7-stage process for changing airspace, the final stage is a post implementation review (PIR) this is for 12 months after implementation. During this period, we collect data on complaints, tracks and altitude of aircraft on this route. This will be provided to the Civil Aviation Authority (as regulators of the airspace) who will decide if the route can be made permanent or if changes are required. You can find out more about the Post Implementation Review on the airspace change portal.

We do recognise that our operations can have an impact on neighbouring communities, and we of course have every sympathy with those affected and I would like to apologise for the disturbance you have experienced.

I do hope this information is of assistance to you.

I am a resident of Rushden in North Hertfordshire and have lived here for nearly 21 years.

During this time, I have never experienced aircraft noise as it is currently and as such I wish to complain.

As I understand it, this is caused by the frequency and altitude of descending aircraft approaching Luton via the new AD6 route.

The background noise has risen to the point where our peaceful rural sounds are drowned out and the frequency of aircraft means that we get little respite from this increased noise.

I am annoyed by the constant noise and can no longer enjoy a peaceful garden. I am now disturbed at night and find it more difficult to sleep. Telephone calls are made difficult when aircraft fly past.

My understanding is that this change has come about without any consultation and that the process lacks any independent governance since LLA and NATS are collecting data themselves before presenting this to the CAA.

Surely this cannot be right. It suggests that data could be manipulated to suit the required outcome for LLA. What consideration is LLA giving to environmental and public health impacts caused by its expansion plans?

Aircraft noise and frequency is now a blight on our peaceful hamlet and its surrounding area.

Further to my previous emails complaining about excessive aircraft noise that is disrupting our village, we continue to be affected by this on a daily basis.

Flights affect us throughout the day and last week I was kept awake by aircraft into the very early hours of the morning. I do not have details as I was trying to get to sleep.

Having moved to rural Rushden to enjoy the peaceful surroundings, the current situation impacts us significantly.

I note that there is a preliminary planning meeting for the proposed Luton Airport expansion to be held on August 10th. Unfortunately, I wont be able to attend.

I do however want my concerns to be taken into consideration.

Whether flights approach from the North, South or West, my house and the village of Rushden seems to be a navigation beacon for flights landing at Luton (see images attached, our house is the blue dot).

Flights do not approach from the East as this is Stansted airports take-off route. Another source of unwelcomed noise.

As I have mentioned previously, I cannot understand why aircraft aren't routed over the main road network, where ambient noise levels are much higher.

Considering the very low ambient noise levels in our area, the impact of aircraft noise is awful. The expansion of Luton Airport will only make this worse and I strongly object to its expansion.

Given recent news events, what consideration is being given to environmental and public health impacts caused by these expansion plans?




Flight examples over 8 Church End, Rushden, Herts, SG90SG. These are a tiny example of flights to show the flight path.
