1 SCOPE OF CULTURAL HERITAGE GAZETTEER

1.1 Overview

- 1.1.1
 This Cultural Heritage Gazetteer comprises a list of heritage assets, located within a defined study area, that are relevant to the cultural heritage assessment for the Proposed Development. The spatial scope of the study area is detailed in Section 10.3 of Chapter 10: Cultural Heritage [AS-077] of the Environmental Statement (ES) and has been agreed with the statutory consultees.
- 1.1.2
 The gazetteer comprises designated heritage assets from the National Heritage

 List for England (NHLE) and non-designated heritage assets from the Historic

 Environment Record (HER) for Hertfordshire County Council and Central

 Bedfordshire Council. The gazetteer also comprises historic landscape features

 and a list of cultural heritage investigations carried out within the defined study

 area.
- 1.1.3 In addition, the gazetteer contains records that are not recorded on NHLE or the HERs and have instead been identified from desk-based assessment carried out for the Proposed Development. These records are identified in the gazetteer in Section 3 of this appendix by the prefix 'AEC'.

1.2 Summary of Impact and Harm

- 1.2.1 While there is no direct correlation between the significance of effect in Environmental Impact Assessment (EIA) terms and the degree of harm referenced in the National Planning Policy Framework (NPPF), it is acknowledged that those assets which are identified as experiencing a significant adverse effect are more likely to experience substantial harm.
- 1.2.2
 As such, assets where a significant effect has been predicted in Chapter 10:

 Cultural Heritage [AS-077] of the ES are further assessed in Appendix D

 Heritage Statement [APP-198] of the Planning Statement [AS-122]. The

 Heritage Statement considers the potential harm to these heritage assets in

 accordance with the NPPF to enable the planning balance to be undertaken in

 weighing harm against the public benefit.
- 1.1.11.1.2.3 As part of the systematic assessment of potential impacts to cultural heritage assets, many heritage assets were scoped out from the impact assessment process as the Proposed Development would result in no impact to their heritage value, either from physical impacts or through changes to their setting. To capture this process, the gazetteer includes a record of the likely effect arising from the Proposed Development for each heritage asset, and also includes a brief rationale for its scoping out from the detailed impact assessment in the ES. Where a potential impact has been assessed in the ES, an assessment of the likely harm is also recorded in the gazetteer.
