1 INTRODUCTION

1.1 Purpose of this document

- 1.1.1 This document has been prepared to support of the application for development consent ('DCO') for the proposed expansion of London Luton Airport ('the Proposed Development'). This application is made by Luton Rising (a trading name of London Luton Airport Limited) ('the Applicant'), owners of the airport.
