1 Introduction

- 1.1 This report provides the response of Luton Borough Council (LBC) as local planning authority (LPA) to various documents that were submitted by the Applicant at Deadline 5.
- 1.2 At Deadline 5 (14 November) some 65 documents were provided by the Applicant (though some of these were duplicates). The five Host Authorities have jointly commissioned consultants in respect of noise (Suono), and draft DCO/legal (Pinsent Masons) and reference is made to comments that have been provided in other documents by those consultants on behalf of all five Host Authorities.
- 1.3 The response only address those documents where LBC (or its consultants) have considered that a further comment is necessary, but also references where those documents may have been covered in other submissions that are provided at Deadline 6.

2 Comments on documents submitted

- 2.1 In the post hearing submissions to ISH8 (Environmental Matters) and ISH9 (Green Controlled Growth), Suono has provided comments on noise on behalf of LBC and the other Host Authorities, which addresses issues raised in the following documents submitted by the Applicant at Deadline 5:

Section 2.2	Design quality	Whilst this section advises that the scheme layout plans [AS-072] demonstrate how the scheme has "responded to the context of the landscape, neighbouring land and property uses, and has considered the need to minimise impact," ultimately this is an outline scheme, with broad parameters and no meaningful detail in relation to design. It is recognised that Table 2.1: Design quality design principles has been updated and now includes reference to Luton Hoo and Someries Castle, however most of the additions to that table are technical compliance criteria, reinforced by the codes and standards contained within Table 4.3: Terminal works design principles.	



It is disappointing that there is no reference to design review as a tool for assessing and improving the design of this nationally significant development, as advocated by paragraph 133 of the NPPF and by Local Plan policy LLP25.
The Council made representations both in ISH8 and ISH10 in relation to the need for design review.

2.1	Green Horizons Park S106	The Section 106 is a matter of ongoing discussion with the Applicant, it was raised at ISH10 and Action Point 19 is being addressed for Deadline 6.
2.2	P19 S106	It is noted that the Applicant has agreed to incorporate some of the controls from the



		Noise Management Plan into the DCO noise controls. Again this was discussed at ISH10, and Action Point 19 requires a summary of the Heads of Terms envisaged within the Section 106 to be submitted for Deadline 6.
2.3	P19 Conditions	Whilst the Applicant has indicated that eight of the conditions associated with the 19mppa planning permission are not considered to be relevant, at the ISH10 session, BDBPitmans on behalf of the Applicant did acknowledge that an issue could arise if Phase 3 had not been completed by the time notice of intention to commence the DCO was served on the Council. This would necessitate an article similar to that of Article 45 associated with the Green Horizons Park permission. There also needs to be in place provision for the protection of the mode share levels that might have been achieved under the updated Travel Plan required by condition 18 for 19mppa, and carbon reduction achieved in line with the Carbon Reduction Strategy secured under condition 19.
