# 1 INTRODUCTION

#### 1.1 Background

- 1.1.1 London Luton Airport Limited, trading as Luton Rising ("the Applicant"), has applied to the Secretary of State for Transport for development consent under section 37 of the Planning Act 2008 ("the Act").
- 1.1.2 The application is for an order granting development consent, known as a Development Consent Order ("DCO"). The draft DCO is referred to as the London Luton Airport (Expansion) Development Consent Order. The DCO, if granted, would authorise an increase of the permitted capacity of London Luton Airport ("the airport") to 32 million passengers per annum (mppa) ("the Proposed Development").

#### **1.2 Purpose of this document**

- 1.2.1 Statements of Common Ground (SoCGs) have been prepared by the Applicant and other parties in line with the Rule 6 letter from the Examining Authority (ExA). The SoCGs provide a record of discussions to date with a number of key Interested Parties and a summary of the matters that are either agreed, subject to ongoing discussion, or not agreed. Drafts of the SoCGs have been shared with the relevant Interested Parties and their comments addressed. The Applicant will continue to work with the Interested Parties and review any matters that are still subject to further discussion as the Examination progresses. Prior to the end of Examination, the Applicant intends to submit a final version of each SoCG.
- 1.2.2 This Statement of Commonality is provided at the request of the ExA to provide an overview of the position between the Applicant and the relevant Interested Parties and a table showing commonality on specific points between the various SoCGs.
- 1.2.3 This document provides a summary of the status of SoCGs at Deadline <u>6</u><del>3</del> (8 <u>December 2023</u><del>5 October 2023</del>).

#### **1.3 Structure of Statements of Common Ground**

- 1.3.1 To ensure consistency in the approach across all SoCGs and provide clarity to the ExA, each SoCG has been produced in a standard format.
- 1.3.2 The SoCGs have the following format:

**Section 1:** provides a background to the document, the parties to the SoCG, and a description of the Proposed Development.

**Section 2:** provides a summary of the consultation and engagement to date between the parties.

**Section 3:** sets out the matters that are agreed, not agreed, and subject to ongoing discussion.

1.3.3 A change notification request was submitted to the Examining Authority on 22 September 2023 [AS-151 and AS-152REP4-031] to update the Drainage Design Statement, following ongoing engagement with Thames Water and the Environment Agency. The Examining Authority subsequently confirmed by way of a Rule 9 letter, issued on 13 October 2023, that the changes could be deemed non-material and accordingly could be accepted into the Examination, requesting that an updated Drainage Design Statement be submitted at Deadline 4. The Applicant submitted the updated Drainage Design Statement at Deadline 4 as requested by the Examining Authority (subsequently corrected at Deadline 5 [REP5-096]). The iterations of the SoCGs submitted at Deadline 3 are based on the existing DCO drainage design strategy and do not take into account initial engagement with Thames Water and the Environment Agency on the proposed design change. The Environment Agency is currently reviewing the documents submitted at Deadline 4 and 5, and as such this iteration of the Statement of the Common Ground, does not fully take into account their current position on the proposal.
