Such narrative relating to landform and built form considerations informing outline design should be complimented by the requirements set out in the Design Principles <a href="#">[REP9-031]</a> document to provide clear direction in terms of massing, rooflines, colour – in broad terms – to indicate how they have and should respond to local character, context or setting to ensure that such considerations are carried through to detailed design.</a></li> </ul> <p><del>The Applicant has not made these changes to Section 3 in <a href="#">[REP8-023]</a>. No changes have been made to Section 3 except for some document reference updates. Comments provided to the Applicant at Deadline 7 within Appendix 1 of the Hertfordshire Host Authorities' Comments On Any Further Information / Submissions Received By Deadline 6 <a href="#">[REP7-085]</a> have not been incorporated.</del></p> <p><del>The updated version therefore adds nothing to the discussion relating to landscape design principle</del></p>
