1 INTRODUCTION

1.1 Background

- 1.1.1 London Luton Airport Limited, trading as Luton Rising ("the Applicant"), has applied to the Secretary of State for Transport for development consent under section 37 of the Planning Act 2008 ("the Act").
- 1.1.2 The application is for an order granting development consent, known as a Development Consent Order ("DCO"). The draft DCO is referred to as the London Luton Airport (Expansion) Development Consent Order. The DCO, if granted, would authorise an increase of the permitted capacity of London Luton Airport ("the airport") to 32 million passengers per annum (mppa) ("the Proposed Development").

1.2 Purpose of this document

- 1.2.1 Statements of Common Ground (SoCGs) have been prepared and developed during the Examination by the Applicant and relevant Interested Parties in line with the Rule 6 letter from the Examining Authority (ExA). The SoCGs provide a record of discussions with those Interested Parties and a summary of the matters that are either agreed, subject to ongoing discussion, or not agreed. Drafts of the SoCGs have been shared with the relevant Interested Parties and their comments addressed. The Applicant continued to engage with the Interested Parties to discuss matters that were still outstanding as the Examination drew to a close.
- 1.2.2 The Applicant has submitted, at various deadlines during the Examination, final versions of SoCGs as they were completed. A number of signed SoCGs have been submitted at Deadline 11 and the remaining signed SoCGs have been submitted on 9 February 2024 ahead of the close of Examination. issued to the Interested Party for signature. The Applicant intends to submit these signed SoCGs tomorrow (Friday 9 February).
- 1.2.3 A Statement of Commonality has been provided, at the request of the ExA, at various deadlines during the Examination to provide an overview of the position between the Applicant and the relevant Interested Parties and a table showing commonality on specific points between the various SoCGs.
- 1.2.4 This document provides a -summary of the status of SoCGs on 9 February 2024,- ahead of the close of Examination Deadline 116 (8 February 20248 December 2023). The Applicant hopes to submit an updated Statement of Commonality to the Examination tomorrow along with the remaining signed copies of the SoCGs.

1.3 Structure of Statements of Common Ground

1.3.1 To ensure consistency in the approach across all SoCGs and provide clarity to the ExA, most (with one or two exceptions) SoCGs have followed a standard format as set out below:

Section 1: provides a background to the document, the parties to the SoCG, and a description of the Proposed Development.

Section 2: provides a summary of the consultation and engagement to date between the parties.

Section 3: sets out the matters that are agreed and not agreed.


