I am unable to find any results of any nuisance noise levels of aircraft approach and holding.

I understood that aircraft were not allowed over **sector** in Bedfordshire.

However, my business and sleep is affected with the noise of aircraft engines.

They seem to be travelling west along the High Street toward the roundabout, sometimes a what I consider to be a very low altitude.

I can hear the engine noise approaching from the east while I am working on the computer at the rear of the house (facing west), and the noise continues until it approaches Ampthill. It can sometimes make a telephone conversation very difficult having to ask the caller to hold until the aircraft has gone..

Just recently I have been awakened many times between 23:00 to 24:00 hours

As I have previously commented I cannot understand why aircraft approaching have to pass over the village and not be controlled by ATC sending them a mile or so to the South and/or North of the village. Is there an issue with Luton ATC not being able to properly direct and controlling flights ?

If this issue is not rectified <u>any increase in air traffic</u> can only exacerbate the frequency of nuisance noise level over and other villages in the flight path.

Additionally, aircraft emissions are a significant contributor to climate change, and their impact is known to be growing faster than any other mode of transportation. Increasing the number of passengers will increase the number of flights and thereby emissions.

Last weekend (22.09.2024), Bedfordshire suffered the worst flooding in its history.
