Planning Act 2008, Section 46 Notification
Proposed Manston Airport Development Consent Order

I write to provide the Secretary of State with notification for the purposes of section 46 of the Planning Act 2008 ('the Act') that RiverOak proposes to commence consultation pursuant to section 42 of the Act in regard to its proposed application for the Manston Airport Development Consent Order ('Manston Airport DCO'). The consultation will begin on <a href="Friday 12 January 2018">Friday 12 January 2018</a> and the deadline for receiving responses is 11.59pm <a href="Friday 16">Friday 16</a> <a href="February 2018">February 2018</a>. This follows a previous statutory consultation held between 12 June and 23 July 2017.

As you are already aware, RiverOak proposes to apply to the Secretary of State under section 37 of the Act for Manston Airport DCO. The application will be for the redevelopment and reopening of Manston Airport as a hub for international air freight which also offers passenger, executive travel and aircraft engineering services.

Based on the addition of 19 aircraft stands from when the airport previously operated, on the basis that the airport is currently unable to operate, this would increase the capability of the airport by well over 10,000 air freight movements per year, which means the Project is classified as a 'Nationally Significant Infrastructure Project' by the Act.

In accordance with section 46 of the Act, RiverOak hereby supplies the Secretary of State with the same information that is being supplied to all relevant consultees identified in accordance with section 42 of the Act, and encloses with this letter the following documents:
