I FIRMLY DISAGREE WITH RSP's PROPOSAL OF OPENING MANSTON AIRPORT AS A CARGO HUB. NOISY FLIGHTS - DAY AND NIGHT - WILL CAUSE A NUMBER OF QUALITY OF LIFE AND HEALTH CONCERNS SUCH AS SLEEP DEPRIVATION AND LUNG/BREATHING CONDITIONS FOR THOSE THAT HAVE CHRONIC LUNG ISSUES SUCH AS [REDACTED] (I'M A SUFFERER) FROM POLLUTION CAUSED BY THE PLANES. THE AIRPORT IS TOO CLOSE TO RESIDENTIAL AREAS; TO HAVE WHAT WILL BE CARGO PLANES FLYING JUST SEVERAL HUNDRED FEET ABOVE HOMES IS TOTALLY UNACCEPTABLE + A SEVERE DANGER IN AN EMERGENCY. THERE IS ALSO CHANCE THAT THE SEVERE NOISE FROM AIR-CRAFT WILL CAUSE VIBRATION VARIICES AND TURBULENCE - THIS HAS ALREADY HAPPENED TO A PROPERTY IN SOUTHWOOD AREA, ST. LAWRENCE, NETHERCOURT AND SOUTHWOOD ARE DIRECTLY UNDER THE FLIGHT PATH WHERE HOME OWNERS COULD BE SUBJECTED TO NOISE LEVELS OF 100db - NEEDLESS TO SAY HOUSE VALUES WILL ALSO FALL. I BELIEVE 3 SCHOOLS ARE ALSO DIRECTLY UNDER THE FLIGHT PATH WHICH WILL ALSO DISRUPT CHILDREN'S LEARNING. IT'S BEEN SUGGESTED THAT A MINIMUM OF 17,000 FLIGHTS ARE EXPECTED OVER THANET - NOBODY SHOULD HAVE TO PUT UP WITH THAT. MANSTON NO LONGER HAS LONGEST RUNWAY NETHER FUEL STORES MEANING CONSTANT STREAMS OF TANKERS ON ALREADY CONGESTED ROADS ESPECIALLY AROUND THE AIRPORT WHERE THE ROAD SYSTEM IS POOR AND WILL ONLY BECOME WORSE DUE TO NEARBY HOUSING DEVELOPMENTS AROUND HAINE ROAD AREA. NEW JOBS WILL BE MINIMAL DESPITE ASSURANCES. FURTHER NOISE WILL COME FROM ICE-FUELING PLANES THE AIRPORT HAS NEVER SUCCEEDED IN THE PAST - PREVIOUS OWNERS HAVE REPORTED LOSSES. INDUSTRY INSIDERS HAVE SAID THE SITE IS NOT AND NEVER WILL BE VIABLE AS AN AIRPORT.
