- I want Kent & Thanet to have the high quality jobs that Manston Airport will bring It will help to raise young peoples aspirations.
- I want my Family to have Aviation related jobs

The most basic evidence I can provide is that my own career. This was possible because I lived between Heathrow and

Gatwick airport. Although few of my employers were related to aviation directly these businesses, including BG

Exploration and Production, were located to be close to the airports. The proximity to the airport enabled the international communications and commercial logistics necessary to promote and carry out business and operations. I

moved to Thanet while Manston Airport was operating and have been disappointed at the lack of employment prospects in

the area following the closure.

- If Manston were to be used for housing, as the owner wants, the infrastructure of Thanet would come to a standstill
- Little or no reliance can be placed on Thanet District Council's Evaluations on the Adequacy of Consultation Representations

To explain. Thanet is in a rain shadow and has little or zero options for expanding its water supply beyond current

capabilities without vast expense. The sheer volumes of housing possible by building on the airport would lead to water

shortages rendering the area uninhabitable for large parts of the year. Evidence of the already critical nature of this

rare and fundamental resource is Southern Water's application for a drought order in January 2018 to enable it to take

water from the River Medway and River Teise and pump into the Bewl reservoir. The text of the order: "Take notice that

due to the threat of a serious deficiency of water supplies in the Kent Medway, Kent Thanet and Sussex Hastings water

supply areas, caused by an exceptional shortage of rainfall, Southern Water Services Limited ("Southern Water") of

Southern House, Yeoman Road, Worthing, West Sussex, BN13 3NX, is applying to the Environment Agency for a drought
