Many thanks for sending the details of forthcoming hearings and ASI.

As a local resident, business and registered Interested Party, I would like to confirm interest in attending and speaking at all of the following, representing Five10Twelve Ltd:

- Open Floor Hearing, 18 March 2019
- Compulsory Acquisition Hearing 1, 20th March 2019
- Issue Specific Hearing 2, 21st March 2019
- Issue Specific Hearing 3, 22nd March 2019

Re: Accompanied Site Inspection (ASI), 19th March 2019

I would also like to confirm my previously stated interest in attending the ASI, specifically at the **Ramsgate Conservation Area**, (marked as site 1 on the list).

I would also request that it be made clear to the ExA the following with regards to the Ramsgate Conservation Area and Heritage Action Zone, (HAZ): This is particularly relevant since I note from the ASI itinerary that the visit to the Ramsgate Conservation Area is listed under "Socio-Economic Issues", whereas it is also directly relevant to Principal Issues regarding Landscape, Design, Archaeology and Heritage. This is a crucial point since it continues a troubling pattern with regards to the Applicant's refusal to acknowledge the existence and importance of the Ramsgate Conservation Area as it relates to this statutory issue, as follows:

1) The circled area provided by the Applicant in its ASI Itinerary (TR020002/D2/ASI) does not cover the whole of the Ramsgate Conservation Area, nor does it make any reference to Ramsgate's designated status as one of only 10 Heritage Action Zones in the country.

2) The Applicant failed to identify or include any part of the Ramsgate Conservation Area or HAZ in its Environmental Statement since this was based on a study area of only 500m - 1km around the site.

a) Further, although Ramsgate Conservation Area was identified in the Applicant's Environmental Statement Main Text Chapters 1-10, (TR02002-00247-5.2),-1as "requiring assessment" along with Conservation Areas in Acol, Broadstairs and Minster, Ramsgate Conservation Area has been completely omitted from the Applicant's Environmental Statement and Table of effects at 9.15 of this document, (page 16). Consequently, whilst Acol and Minster are mentioned, the largest Conservation Area in Kent, comprising of more than 900 Listed Buildings, has been completely omitted from the Environmental Statement, almost as if it does not exist.

I am therefore delighted that the ExA will be visiting Ramsgate Conservation Area to verify its existence with their own eyes and I would politely request that the Applicant explain why it was omitted from its Environmental Statement since this can surely not be a mere oversight.
