Subject: Manston Airport. DCO

Chairman and Panel Members...

Thank you for giving me the opportunity to speak in support of the DCO application for Manston Airport.

I am a serving Councillor on Thanet District Council and also Ramsgate Town Council.

I have lived under the flight path for nearly 20 years.

This facility is, in my view, going to waste and it could be discarded for no good reason.

It is well documented that the area covered by the airport is completely unsuited to a large housing conurbation.

A functioning airport offers a chance for real jobs and investment and economic benefit to Thanet as well as considerable benefits at a national and international level.

Manston Airport would offer ancillary jobs and educational training and development through engagement with local universities not only in terms of study, training and practice but also a very real opportunity to build a quality tear down facility which would remove and refurbish many aircraft components.

I speak as a former Army helicopter technician who worked on helicopters and Fixed wing aircraft and I firmly believe that the education and training opportunities are a given as is the business potential for the local Chambers of Commerce who also see the value of as functioning airport

Delivery companies and suppliers would also benefit from increased activity and Tourism would undoubtedly receive a boost.
