Further to the open floor meeting of 18th March I would like to reaffirm the question I would like the inspectorate to ask RSP as follows:-

I request the panel question RSP why they employed Dr Sally Dixon as their sole 'expert'.

Dr Dixon has previously worked with Mr Tony Freudmann and has a history of providing flawed analysis on the prospects of Manston, as such Dr Dixon does not represent a truly independent opinion.

has submitted a personal response to this panel (RR-0496) unequivocally declaring her support for the proposal, this seems extremely unusual behaviour for an "independent" witness and calls into further question her evidence, reports and analysis that have been submitted to the examining authority

Dr Dixon's expertise seems to rest on her PhD thesis, she has little or no actual practical experience in the field and in fact would appear not to be an expert as would be understood in the real world. Dr Dixon's work appears to focus heavily on the ways in which airport development can be advocated and influence exerted through the management of stakeholder opinion. This is extremely troubling as her work appears designed to subvert the open, transparent and evidence-based approach to full stakeholder involvement in decision-making. I would expect the panel to ask RSP why they have chosen to appoint someone with this particular focus in their work, particularly given the context of the relative deprivation of Thanet, the urgent need for regeneration in the area given the fact that there is already a credible alternative plan in the making by the lawful owners.

I also mentioned at the meeting that I have had in the past the council noise monitor on my roof and that the readings from this meter registered at 100db+. This is significantly louder than the noise RSP is saying should be expected. Obviously these are real world readings rather than theoretical readings that have been made up by RSP. I attach the relevant

correspondence from the council confirming these readings. I urge you to challenge RSP regarding the level of noise residents will be subjected to, day and night.

I'm struggling to understand how it is that we are at the end of a night time flying consultation and yet the council has not published any actual noise data from flights that come across Ramsgate.

After years of complaining a council noise monitor was put on the roof of my house several months ago. I have been provided with readings from this noise monitor and the results are quite shocking, yet not unexpected, as I have been complaining about this for years. From the readings it is clear that the airport has submitted false information to TDC in respect of their application for night flights, yet this has not been challenged or contested. The council has in its possession very accurate noise readings, as set out below, why is it not using this information?

I would like confirmation that all councillors will be provided these noise readings so that they are aware of the level of noise that residents will be exposed, how else are they supposed to make a decision? If they are going to make a decision that will impact peoples health they should do it based on facts not fiction.

I would like confirmation that the information will be published on the councils web site so that members of public are aware of the level of noise rather that they are exposed to. I would also like to know what assessment the environmental health officers have made and the results of any impact analysis.
