At 4.21 The Applicant states:

"There are no alternatives that meet the requirements of runway length, proximity to London but **outside London airspace**.." (bold added for emphasis)

However the CAA Airspace Change portal states that:

"In order to recommence safe flight operations at Manston Airport, the implementation of appropriate Instrument Flight Procedures (IFP) and airspace is required. Due to the airport's location, the IFP (routes into and out of the airport) should align with Future Airspace Strategy Implementation - South (FASI(S)) and the London Airspace Management Programme (LAMP). The airspace solution aims to provide an appropriate degree of protection to aircraft during the critical stages of flight; take-off and landing".

Therefore it will seem that from the CAA ACP portal that Manston is not outside London airspace but rather that "due to the airport's location, the IFP (routes into and out of the airport) should align with <u>Future Airspace Strategy Implementation - South (FASI(S)) and the London Airspace Management Programme (LAMP)".</u>
