Dear PINS

1 In 2014 Draft Manston Airport Investor Paul FAY withdrew and made crime complaint alleging FRAUD in Manston Acquisition Plans.

2 This is still an open Fraud and Assault police inquiry incorporating one cold case assault of 1996 and two crime complaints alleging misconduct in public office.

3 There is now a Joint CPS/Police scoping inquiry into Corporate Manslaughter QEQM Margate Maternity Tragedies.

4 Common to all of above is the Manston Aquifer sourced Public Water Supply

5 In 2018 Thanet District Council admitted to PINS that Manston site is contaminated and admitted to failure to protect the water supply adit.

6 Thanet District Council undertook to conduct a review of their Contaminated Land Strategy

7 De Facto Thanet District Council are conducting the review in SECRET until 2023. They have identified over 600 contaminated Thanet sites ... kept secret.

8 The failure to comply with Environmental Protection Act 1990 .. from 1990 to 2023 ... means no meaningful cumulative impact or precautionary principle or risk to health assessment was ever possible

9 In 2019 I called in DEFRA Drinking Water Inspectorate to secure a ban on Manston Aquifer as a Public Water Source.

10 The Environment Agency is planning its enforcement of United Nations Stockholm Convention re Persistent Organic Pollutants. In Thanet Manston would have been significant main source of PFAS chemicals. PCBS would have been sourced by GEC toxic storage at Westwood and toxic burials at Pegwell Landfill which is now Pegwell Nature Reserve.

11 In addition to the two "POPs" there was huge aquifer contamination by CYCLOHEXANONE of Rumfields Public Water Supply Aquifer leading to ban on use of that aquifer 1993.

12 The discovery of SERICOL Cyclohexanone leakage (Hundreds of Tonnes over an

undetermined period) arose from theft inquiry. Hence KENT POLICE knew about this when three years later 1996 ex Cllr Margaret MORTLOCK was assaulted ... at a time she was drafting an expose' of Thanet District Council alleging non compliance with 1990 Environmental Protection Act and Development on Contaminated Land. The most serious alleged site being QEQM Hospital Expansion whose opening ceremony was also 1996.

The QEQM on allegedly contaminated ground with construction mortar mixed with Manston and (up to 93 Rumfields) sourced water supply.

13 The contaminants so far mentioned all carry health risks especially to foetal and maternal health. There remains questions re THOR Mercury Chemicals especially Weapons of Mass Destruction mercury products. The factory is even closer to QEQM than Sericol and former GEC.

14 The NHS expert inquiry QEQM maternity tragedies the KIRKUP Inquiry has scheduled research into the contaminants waterborne and environment borne.

15 On the face of it in 1996 et seq there was a failure by Kent Police to link The MORTLOCK assault to SERICOL inquiry. A failure with Terrorism Law implications.

16 The circumstances, in which Manston aquifer remained in use as PWS after PFAS warnings from DEFRA 2007 and Public Health England 2009 ... would properly now be part of Corporate Manslaughter Inquiry. As well as the Fraudulent Acquisition Inquiry.
