## Economic Crime (Transparency and Enforcement) Act 2022 / Reputational Risk

- A summary chart detailing Riveroak Strategic Partner's (RSP) secretive chain of shell companies masking its anonymous foreign owners is attached at Appendix 001. This is based on the most up-to-date filings at Companies House.
- In its most recent filings, RSP states that its Ultimate Controlling Party (UCP) is HLX Nominees Limited - a company incorporated in the British Virgin Islands<sup>2</sup>.
- 3. HLX Nominees Limited's majority shareholders the 'warm bodies' that own and control RSP and therefore the Manston site and the proposed freight airport are unknown.
- 4. There is a reputational risk with regards to aligning with RSP's founding Director and spokesperson, Tony Freudmann, given his career history. This includes directorships of 18 dissolved companies<sup>3</sup> including numerous failed aviation, airport and travel businesses over a period of 23 years since being struck off the solicitors' roll for misappropriation of client funds.

## National Airports / Leveling Up

- 5. The South East is already a highly competitive market for aviation, with 10 existing airports operating in the region, (Biggin Hill, Bournemouth, Gatwick, Heathrow, London City, Luton, Lydd, Southend, Stansted, Southampton). This list includes 5 UKNET airports.
- 6. The aviation sector is currently struggling to fill existing vacancies, to the extent where British Airways, as just one example, has cancelled 13% of its planned capacity<sup>4</sup>.
- 7. Supporting air freight at airports closer to manufacturing regions in the midlands and the North of England has been recognised as a need in the Steer Group report for Airlines UK, Assessment of the Value of Air Freight Services to the UK Economy<sup>5</sup>.
- 8. Opportunities for supporting air freight services have been identified in expansion plans for East Midlands Airport, Manchester Airport, Doncaster Sheffield Airport and as part of the investment plan for Teeside Airport as part of Teesside Freeport<sup>6</sup>.

#### **Alternative Use**

- 9. The leaders of six Conservative-controlled councils recently wrote to the SoSFT regarding road congestion across Kent and surrounding Dover, with proposed urgent solutions including much-needed lorry parks and increased rail freight<sup>7</sup>.
- 10. The lorry park function was previously successfully delivered at the Manston site via a Special DCO<sup>8</sup> and historically has done so since 2015.
- 11. Such alternative use of the Manston site is consistent with the **Transport for the South East Freight, Logistics and Gateways Strategy**, published in May 2022. The only reference to the Manston site in this entire 193 page report is in the context of the site's use as a lorry park as part of Operation Brock<sup>9</sup>.

#### **Procedural Issues**

- 12. The UK Planning Inspectorate Examining Authority (ExA) Recommendation Report recommended refusal of the DCO on multiple grounds<sup>10</sup>.
- 13. The original decision which went against this recommendation was quashed by High Court Order on 15 February 2021<sup>11</sup>.
- 14. The SoSFT commissioned an Independent Assessor's report (**IA Report**) authored by Ove Arup following the High Court Order.
- 15. The IA Report agreed with the ExA Recommendation Report and concluded that there was not sufficient need for the development at the Manston site, additional to (or different from) the need which is met by the provision of existing airports<sup>12</sup>.
