Thank you very much. Are you signed up to receive update alerts from the Planning Inspectorate on the Manston project? I'm not sure whether you can only do that at the start of the examination process or whether the Planning Inspectorate is able to add you now, but I think it is worth asking the Planning Inspectorate – I would try the Manston casework team in the first instance at [manstonairport@planninginspectorate.gov.uk](mailto:manstonairport@planninginspectorate.gov.uk) if you are not already signed up.

The next step for the Department following the 28 March deadline is to analyse the responses received, and following this analysis determine whether any further action is required. I really do appreciate that the lack of a set timetable for the re-taking of the decision is frustrating for anyone with an interest in the application. It is difficult, however, for the Department to set out a meaningful timetable as timings rely on factors outside of our control such as the number of responses we receive to our consultations, the quality of the information in those responses, the time and effort required to analyse the responses, and whether any further action/consultation is required.

Following the Order made by the High Court on 15 February 2021 which quashed the Secretary of State's decision of 9 July 2020 to grant consent for the Manston Airport development consent order application, the Secretary of State is required to redetermine the application.
