Thank you for confirming that this has been resolved.

I'd be grateful if you could explain the delay in posting the application on line.

The Secretary of State was notified of the intention to request the alterations in May. Subsequent documentation sets out a consultation period of 12 July 2023 to 25 August 2023. The list of dates on which Regulation 6 Notices were published ranges from Wednesday 12 July for the London Gazette, Deal and Dover, to Friday 14 July for Thanet - the area most affected by RSP's proposals. Email notification of the application was apparently only sent out on 20 July 2023, more than a week into the consultation period although still allowing a 28 day period for responses.

I apologise for raising this but you will probably be aware that the DCO has been subject to judicial review and we are awaiting the judges decision. Understandably, any potential change by RSP is likely to cause concern.
