Notification of proposed application under section 46 of the Planning Act 2008

On 17th June 2019, pursuant to our obligations under section 46 of the Planning Act 2008, we provided you with a USB stick containing a full suite of documents that will be consulted on during the Airport Expansion Consultation (AEC).

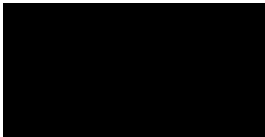
