Re. Gatwick Airport Northern Runway Project (PINS Reference No TR020005)

Horsham District Council is one of the local authorities identified by Section 43(2) of the Planning Act 2008 and we are writing to you regarding the Gatwick Airport Northern Runway Project.

Officers are currently reviewing the suite of application documents available on the Planning Inspectorate's website and we wish to highlight a factual error regarding Horsham District Council's involvement in the pre-application engagement the Applicant (Gatwick Airport Ltd) has undertaken prior to submission. In the Environmental Statement Chapter 12: Traffic and Transport (pp.40-43) and pp.39-40 of the Transport Assessment, the Applicant has omitted to identify the involvement of Horsham District Council in the Topic Working Group meetings. This is incorrect and officers from the Council have been invited to and have attended the Traffic & Transport Topic Working Group meetings arranged with the local authorities.

It is important that this is accurately referenced to provide assurance to the communities that we represent of our active engagement and participation in this process. The Council therefore requests that the documents referenced are corrected by the Applicant or if this is not possible, that the omission of this information being an error is acknowledged as a matter of public record.
