This will cause a deterioration in travel conditions for airport and non-airport passengers on busy rail services, and reduce the ability of the project to meet appropriately sustainable mode share targets.

5 Car parking assessment - The applicant has failed to set out a convincing car parking strategy which will deliver a sustainable surface transport mode share for the project, both at the airport and in the surrounding area.

6 Modal targets and controls - The surface transport mode share targets are weak, failing to prevent an increase in car traffic. The applicant has failed to set out a convincing package of transport measures which will deliver sustainable transport modal targets.
