Application for a Development Consent Order by Gatwick Airport Limited for the Gatwick Airport Northern Runway Project (Ref. TR020005) (the "Application") – Request for proposed changes to the application for development consent

On 27 November 2023, the Applicant notified the Examining Authority of three proposed changes that have been identified by the Applicant and are requested to be made to the application [AS-112] and AS-113].

Further to this notification, please find enclosed the Applicant's formal request to the ExA to change the Application (the "Change Application"). This Change Application relates to three proposed changes to the Application namely:

- Project Change 1: Extension to the design parameters for the North Terminal International Departure Lounge (NT IDL) proposed southern extension.
- Project Change 2: Reduction in height of the proposed replacement Central Area Recycling Enclosure (CARE) facility and change in its purpose.
- Project Change 3: Revision to the proposed water treatment works.

The **Change Application Report** (Doc Ref. 9.2) hereby submitted provides a detailed description of each proposed change, the need for the change and the environmental appraisal. None of the proposed changes require a change to the Order land and the Infrastructure Planning (Compulsory Acquisition) Regulations 2010 are therefore not engaged.

The submission of this Change Application also follows non-statutory consultation carried out by the Applicant on the proposed changes, which took account of the ExA's Procedural Decision [PD-008] dated 4 December 2023 and is detailed further in the submitted **Consultation Report Addendum** (Doc Ref. 9.3).

The documents submitted as part of this Change Application are set out below and has been collated by references to Figure 2b of the Planning Inspectorate's Advice Note Sixteen (Version 3, March 2023¹). No additional consents or licences to those that have been identified in the **List of Other Consents and Licences** [APP-264] are required as a result of this Change Application.
